Administration	Port Putnam	The Port Infrastructure Development Plan funded by a Federal Grant from the Maritime Administration is nearing completion. The final product will be presented to the Port Authority at a public meeting. Port staff is working diligently on having infrastructure projects started to facilitate the resumption of commercial cargo traffic at Port Putnam
Animal Control	Facility	The main office building and kennel buildings are currently under construction and moving along towards completion.
Parks & Recreation	John Theobald Sports Complex	One new shade structure between the pickleball and basketball courts has been ordered. An additional new shade structure outside of the pickleball courts fence and next to volleyball courts is waiting on permits for installation.
Parks & Recreation	Project Play	The rope bridge, transglide, and spiral tube slide is set to be fixed within a few weeks.
Parks & Recreation	Etoniah Community Park	A new shade structure has been ordered and we are waiting on delivery and installation.
Parks & Recreation	Bostwick Community Park	A new shade structure has been ordered and we are waiting on delivery and installation.
Parks & Recreation	West Putnam Sports Complex	A purchase order to dig a new well & renovate the infields have been issued. A user group who desires to be the primary user and develop a baseball program will present their proposal to the Recreation Advisory Board in December.
Planning and Development	Evaluation and Appraisal Report	Evaluation and Appraisal Report (EAR) Comprehensive Plan Amendment: Consultation services provided by Northeast Florida Regional Council. State Coordinated Review transmitted on October 24, 2024. Adoption hearing expected in the first quarter of calendar year 2025.
Planning and Development	Traffic Count	Collection of trip data from 80+ roads throughout the County. Awarded to Carnahan Proctor and Cross. The field work is complete. Consultants are processing the data for each collection site and will start building out the analysis tables. I anticipate this will be ready by the first week in December 2024.
Planning and Development	Impact Fee Study	RFQ 23-26 approved by BOCC to engage Alfred Benesch Consulting Services. Data collection is nearing completion. If all items can be delivered within the next couple of weeks, the Consultant should be able to submit the draft report by the end of March. Adoption hearing(s) expected in the second quarter of calendar year 2025.
Public Works	Ft Gates Ferry Landing	The FDOT bridge report was obtained for the landing on the west side. County engineer is in the process of designing the repairs needed. No funding source has been identified.
Public Works	St. Johns Ave Resurfacing Palm Ave to CSX Crossing @ Palatka Fire Dept.	Phase 1 in final FDOT acceptance/close out. Phase 2 began construction on 6/10/24. Time extension granted due to hurricanes. Last day of contract is now 4/1/25. Project construction moving smoothly.
Public Works	Dirt to Pave 2022	This project was split into 2 phases due to the water expansion project in Paradise Point area of San Mateo. The design of phase 2 roads, which include Fisherman, Creekside, Edgewater, Paradise Point, and Paradise Circle is completed. Construction is 90% complete.
Public Works	Dirt to Pave 2023	Survey and design completed in house. Construction was awarded to 3 contractors. Copper Roads already in construction. Scheduling pre-construction meetings with remaining contractors: Halifax and North Florida Emulsions.
Public Works	Dirt to Pave 2024	Survey and design in progress in house. Anticipate bid documents in January 2025.
Public Works	East Putnam Drainage and Flooding Mitigation - Phase 4	Construction has been completed.
Public Works	St. Johns Ave Drainage Improvements SR19 - CR309C	All segments substantially complete. Final walk through scheduled for 12/12/24. The project is on schedule for the December 2024 deadline.
Public Works	CR315 Resurfacing Project from SR 20 to SR 100	Project is 85% complete
Public Works	CR315 Resurfacing Project-Design from SR 20 South to County Line	Design in process with completion anticipated February 2025.
Public Works	Port Buena Vista Waste Water Treatment Plant Conversion and Sewer Main Extension	Project is complete.
Public Works	Paradise Point Sewer System Hardening and Generator Installation	Currently working with DEP to change scope of work.

Public Works	East Palatka Watermain Expansion - ARPA funded	Project is 10% Complete. Estimated completion date is December 22, 2024.
Public Works	Putnam County Water Infrastructure Project - US Army Corp of Engineers Funded	Waiting for USACE to finish environmental studies. Expected start date is February 2025.

Public Works	HMGP Putnam County Blvd Lift Station Generator	Design was completed in house. Bids are due for the project on 12/11/2024.

Public Works	Countywide Resurfacing - FY23	Construction was awarded to 3 contractors and work is 85% complete.
